I HEREBY IRREVOCABLY RENOUNCE ANY CLAIMS, OF WHATEVER NATURE, THAT I OR ANY OF MY NEXT-OF-KIN OR ANY MINOR UNDER MY SUPERVISION OR CONTROL FOR THE EVENT, MAY BRING AGAINST TSASA OR THE OWNER OF THE SHOOTING RANGE AND I HEREBY INDEMNIFY AND HOLD TSASA AND THE OWNER OF THE SHOOTING RANGE HARMLESS FROM ANY CLAIMS THAT I, MY NEXT OF KIN OR ANY MINOR UNDER MY SUPERVISION OR CONTROL MAY BRING. - IT IS REQUIRED THAT ALL LEARNERS ATTEND PSIRA ORIENTATION CLASSES ON WEDNESDAY AND THURSDAY FOR THE GRADE THEY WILL BE WRITING ON THE SAME FRIDAY.
- IT IS REQUIRED THAT ALL FIREARM TRAINING LEARNERS ATTEND ORIENTATION CLASSES FOR LEGAL ON WEDNESDAY AND HANDLE AND USE OF FRIDAY OR SATURDAY MORNING BEFORE WRITING THE EXAMS.
